### STATEMENT OF REASONS

### The request

You made an application for assessed disclosure of 15 July 2020 received by the Department of Justice by email of the same date.

You sought to have the application fee waived under section 16(2)(b) of the Act as you are a Member of Parliament acting in connection with your official duty. I agree that it is appropriate to waive the fee in this instance.

You requested the following information regarding the review of Tasmania's *Electoral Act 2004* and associated laws:

- 1. All public submissions and feedback received (excluding submissions 01-04 currently posted on the Department of Justice website);
- 2. Project plans, project updates, project management timelines and projections and any associated information including but not limited to drafts, briefing notes, meeting records and papers and correspondence (written and electronic); and
- 3. Any other information relating to the disclosures and electoral expenditure components of the review.

#### The documents

A Schedule of Documents responsive to your request is at Attachment A.

I note that there may be a number of documents included in the Schedule which may not be within the scope of the application. These documents have been included for the purposes of transparency as they cannot be readily redacted from the material that is within the scope of the application.

### The decision

I am refusing your application in relation to item I.

For the purpose of the application, I am treating items 2 and 3 as being the same. I have decided to exempt information in those items from disclosure.

### Reasons for decision

Item I - All public submissions and feedback received (excluding submissions 0.1-0.4 currently posted on the Department of Justice website).

I am refusing your application under section 12(3) of the Act which provides relevantly:

Assessed disclosure is the method of disclosure of last resort and –

- a) ...
- b) ...

- c) the principal officer of a public authority ... may refuse an application made in accordance with section 13 if the information that is the subject of the application
  - (i) ...; or
  - (ii) will become available, in accordance with a decision that was made before receipt of the application, as a required disclosure or routine disclosure within a period of time specified by the public authority or Minister but not exceeding 12 months from the date of the application.

I note that it is proposed to publish all submissions on the Department of Justice website by July 2021 at the latest.

Item 2 - Project plans, project updates, project management timelines and projections and any associated information including but not limited to drafts, briefing notes, meeting records and papers and correspondence (written and electronic)

Item 3 - Any other information relating to the disclosures and electoral expenditure components of the review

In relation to items 2 and 3, I have decided to exempt information from disclosure under sections 26, 27, 31, 34 and 35 of the Act.

# Section 26(1) of the Act provides:

Information is exempt information if it is contained in -

- a) the official record of a deliberation or decision of the Cabinet; or
- b) a record proposed by a Minister for the purpose of being submitted to the Cabinet for consideration; or
- c) a record that is a copy of, or a copy of part of, a record referred to in paragraph (a) or (b); or
- d) a record, the disclosure of which would involve the disclosure of a deliberation or decision of the Cabinet, other than a record by which a decision of the Cabinet was officially published.

# Section 27(1) of the Act provides:

Information is exempt information if it consists of -

- a) an opinion, advice or a recommendation prepared by an officer of a public authority or a Minister; or
- a record of consultations or deliberations between officers of public authorities and Ministers –

in the course of, or for the purpose of, providing a Minister with a briefing in connection with the official business of a public authority, a Minister or the Government and in connection with the Minister's parliamentary duty.

### Section 31 of the Act provides:

Information is exempt information if it is of such a nature that the information would be privileged from production in legal proceedings on the ground of legal professional privilege

# Section 34 of the Act provides:

Information is exempt information if -

- a) its disclosure under this Act would prejudice relations between
  - i) two or more States; or
  - ii) a State and the Commonwealth; or
  - iii) the Commonwealth or a State and any other country; or
- b) the information was communicated in confidence to
  - i) a public authority; or
  - ii) a person on behalf of the public authority –by –
  - iii) the Government or an authority of the Commonwealth, of another State or of another country; or
  - iv) a person on behalf of the Government or an authority of the Commonwealth, of another State or of another country —

and its disclosure would be reasonably likely to impair the ability of a public authority or Minister to obtain similar information in the future.

## Section 35(1) of the Act provides:

Information is exempt information if it consists of -

- a) an opinion, advice or recommendation prepared by an officer of a public authority; or
- b) a record of consultations or deliberations between officers of public authorities; or
- c) a record of consultations or deliberations between officers of public authorities and Ministers —

in the course of, or for the purpose of, the deliberative processes related to the official business of a public authority, of a Minister or of the Government.

Sections 34 and 35 of the Act are subject to the public interest test in section 33 of the Act – i.e. information will only be exempt if it is contrary to the public interest to disclose that information. Sections 26, 27 and 31 are not subject to that test.

#### Section 26

Signed Cabinet Briefs are exempt under section 26(1)(b) of the Act and are identified in items 253, 283, 926, 942 and 959.

Draft Cabinet Briefs are exempt from disclosure under section 26(1)(d) of the Act as their disclosure would necessarily involve the disclosure of a deliberation of Cabinet. Alternatively, such documents are exempt under section 35 of the Act as they are internal deliberative in nature.

Items 3, 141, 317, 324, 435, 943, 944, 960 and 961 are records, which if disclosed, would involve the disclosure of a deliberation of decision of Cabinet, are exempt under section 26(1)(d) of the Act.

#### Section 27

Items 978 to 982 are Parliamentary Briefings and item 983 is a Budget Estimates Brief. These documents are exempt under section 27(1)(a) of the Act as they consist of opinion and advice prepared for the purpose of providing the Attorney General with a briefing in connection with the Attorney's parliamentary duty.

### Section 31

Legal professional privilege attaches to confidential communications between a person and his or her lawyer made for the dominant purpose of giving or obtaining legal advice or the provision of legal services: Daniels Corporation International Pty Ltd v Australian Competition and Consumer Commission [2002] HCA 49, at para 9. Waterford v The Commonwealth of Australia [1987] HCA 25 confirmed that legal professional privilege extends to confidential professional communications between government agencies and their legal representatives if made with the requisite purpose.

I consider that emails and letters between Departmental officers and the Solicitor-General were generated for the predominant purpose of obtaining legal advice and are consequently exempt from disclosure under section 31 of the Act.

### Section 34

Item 272 contains information provided by the Commonwealth Australian Electoral Commission regarding recent electoral reforms.

I consider that this information was communicated on the understanding that it was provided in confidence and was not intended to be made public when it was communicated. Further, I consider that disclosure of such information would be reasonably likely to impair the ability of the Department to obtain other information in the future.

Section 34 of the Act is also subject to the public interest test in section 33 of the Act.

I consider that the following Schedule I factors weigh in favour of disclosure:

- a) the general public need for government information to be accessible;
- b) whether the disclosure would contribute to or hinder debate on a matter of public interest;
- c) whether the disclosure would inform a person about the reasons for a decision;
- d) whether the disclosure would provide the contextual information to aid in the understanding of government decisions; and
- f) whether the disclosure would enhance scrutiny of government decision-making processes and thereby improve accountability and participation.

I consider that the following Schedule I factor weighs against disclosure:

n) whether the disclosure would prejudice the ability to obtain similar information in the future;

The overriding public interest consideration in the current context is the ability of officers in different jurisdictions to be able to freely and frankly exchange information. The disclosure of such information would likely prevent such exchanges from occurring, with a consequent detrimental impact on good decision making. Further, it would also lead to a reluctance to

document the reasons for decision, with a consequent loss in transparency in the decision-making process.

#### Section 35

I consider that a significant number of items contain information which is deliberative in nature, including:

- emails between officers recording consultation;
- Minutes to the Attorney-General;
- drafts of the Interim and Final Report on Electoral Act Review; and
- draft Cabinet Briefs and Minutes.

In Re Waterford and Department of Treasury (No. 2) (1984) 5 ALD 588 at 606: I AAR I at 19-20, the Commonwealth AAT relied on the Shorter Oxford English Dictionary meaning of "deliberation" as "the action of deliberating: careful consideration with a view to decision" and said:

The action of deliberating, in common understanding, involves the weighing up or evaluation of the competing arguments or considerations that may have a bearing upon one's course of action. In short, the deliberative processes involved in the functions of an agency are its thinking processes - the processes of reflection, for example, upon the wisdom and expediency of a proposal, a particular decision or a course of action. Deliberations on policy matters undoubtedly come within this broad description. Only to the extent that a document may disclose matter in the nature of or relating to deliberative processes does s.36(1)(a) come into play.

It by no means follows, therefore, that every document on a departmental file will fall into this category. Section 36(5) provides that the section does not apply to a document by reason only of purely factual material contained in the document (see, in this regard, the Full Court decision in Harris (1984) 51 ALR 581). See also s.36(6) relating to reports and the like. Furthermore, however imprecise the dividing line may first appear to be in some cases, documents disclosing deliberative processes must, in our view, be distinguished from documents dealing with the purely procedural or administrative processes involved in the functions of an agency. A document which, for example, discloses no more than a step in the procedures by which an agency handles a request under the FOI Act is not a document to which s.36(1)(a) applies.

Section 35(2) of the Act provides that section 35(1) of the Act does not include purely factual information. In Re Waterford and the Treasurer of the Commonwealth of Australia (No 1), it was also held that the word 'purely' has the meaning of "simply" or "merely". Consequently, the material must be "factual" in fairly unambiguous terms. To be excluded from exemption the material must not be inextricably bound up with a decision-maker's deliberative processes.

Given the above, I consider that emails between Departmental officers and emails between Departmental officers and Ministerial advisors contain a mixture of:

- opinions, advice or recommendations; and
- records of consultations or deliberations,

between officers of public authorities, such that they are either partially or exempt in full from disclosure. In some cases, factual information is present in the same documents, but there are

instances where that information cannot be disclosed as it is inextricably bound with the deliberative processes.

I also consider that Minutes and Briefing Notes to the Minister contain a mixture of opinions advice or recommendations between officers of public authorities and a Minister such that they are exempt in full from disclosure. In some cases, factual information is present in the same documents, but there are instances where that information cannot be disclosed as it is inextricably bound with the deliberative processes.

Finally, I consider that draft documents – including draft letters, Minutes and Briefing Notes and Cabinet Briefs - and are deliberative by their very nature and are exempt.

Section 35 of the Act is subject to the public interest test in section 33 of the Act - i.e. information will only be exempt if it is contrary to the public interest to disclose that information. The matters which must be considered in deciding if the disclosure of the information is contrary to the public interest are specified in Schedule I but are not limited to those matters.

I consider that the following Schedule I factors weigh in favour of disclosure:

- a) the general public need for government information to be accessible;
- b) whether the disclosure would contribute to or hinder debate on a matter of public interest;
- c) whether the disclosure would inform a person about the reasons for a decision;
- d) whether the disclosure would provide the contextual information to aid in the understanding of government decisions; and
- f) whether the disclosure would enhance scrutiny of government decision-making processes and thereby improve accountability and participation.

I consider that there are no Schedule I factors weighing against disclosure.

Notwithstanding this, it is contrary to the public interest to disclose the information. The overriding public interest consideration is the need to ensure that there is a frank exchange of views between officers when making decisions. The disclosure of consultations or deliberations between officers would likely prevent such exchanges from occurring, with a consequent detrimental impact on good decision making. Further, it would also lead to a reluctance to document the reasons for decision, with a consequent loss in transparency in the decision-making process.
