Right to Information application - Minister for Environment and Climate Change - climate change discussions

I refer to your request dated 29 July 2022 directed to the Minister for Environment and Climate Change, the Hon Roger Jaensch MP under the *Right to Information Act 2009* seeking:

- ... date, location and attendee details of all Ministerial diary appointments held since 19 May 2021 for the purpose of discussions involving climate change policy including, but not limited to, the *Climate Change (State Action) Act 2008* review, and the *Climate Change (State Action) Amendment Bill 2021*, and which involved:
 - a) One or more industry stakeholders, including but not limited to registered lobbyists; and
 - b) One or more non-industry and community stakeholders.

I am a delegated RTI Officer of the Minister for Environment and Climate Change, the Hon Roger Jaensch MP, under the provisions of section 21 of the RTI Act.

Searches of the Minister's diary have been undertaken, and diary appointments were identified and subsequently assessed to determine whether they fell within the scope of the application. I have determined that 26 diary appointments fall within the scope of your request. Relevant details have been extracted in accordance with section 18(3)(b) of the RTI Act and provided in the attached schedule (Attachment A).

Following a conversation with Kurt Joyce of your office on 12 September 2022, I determined that for a diary appointment to be in scope, it needed to satisfy the following requirements:

- be held on or after 19 May 2021; and
- be for the purpose of discussions; and
- relate to climate change policy; and
- include one or more industry stakeholders (including registered lobbyists); and / or
- include one or more non-industry and community stakeholders.

I have taken the term 'industry stakeholder' to mean a stakeholder with an interest in the climate change industry that can either influence or be affected by climate change policy - for example, suppliers, manufacturers, agricultural organisations, governments or industry associations.

I have taken the term 'community stakeholder' to mean an individual person with an interest in the development of climate change policy / the climate change industry.

I have taken the term 'non-industry stakeholder' to mean a stakeholder that does not fall within the two categories above.

Due to the nature of ministerial diary appointments, many staff within the Minister's Office are invited to meetings that the Minister attends for the purposes of providing support to the Minister, for example diary managers and advisers. I have taken staff within the Minister's Office to be an extension of the Minister and therefore I have not considered ministerial staff to be industry / non-industry / community stakeholders.

Further, diary entries contain information regarding people invited to appointments, however they do not contain information regarding those individuals that attended on the day. As there is no record within the Minister's Office that contains information regarding attendees, I have therefore determined that it would be appropriate to provide you with information regarding 'invitees'.

Review

Should you wish to lodge an application to the Ombudsman for an external review of my decision, you may do so under section 45 of the RTI Act. An application for external review must be made in writing within 20 working days of receipt of this letter. You will be taken to have received this letter via email on the date of this letter.
