The Tasmanian sustainably farmed salmon sector is a strong, united and vibrant primary industry, with a value of almost one billion dollars to the state. We are Tasmania's largest farming sector and Australia's largest fishery.

The industry remains committed to work above and beyond compliance levels that are currently set by our Tasmanian Government regulators including the Environment Protection Authority (EPA). This is driven by a commitment to protecting Tasmania's environment, caring for our fish welfare and future proofing our sector.
