## Tasmania renews its sponsorship of footy in the US

Tasmania will again be the face of the AFL in the US after the government announced its sponsorship agreement would be extended another three

Premier Jeremy Rockliff said the extension of the United States Australian Football League (USAFL) sponsorship was building on the momentum for AFL in the state, as passions for the sport run deep.

"This commitment comes at a perfect time, as momentum builds around the debut of our Tasmania Devils football team into the AFL for the 2028 season," Mr Rockliff said.

He said the alliance had proved mutually beneficial over the past two years, creating "valuable opportunities" for Tasmanian businesses to connect with the US market which he said was Tasmania's third most valuable goods export market and an important tourism market.

The sponsorship will be in place until the end of the 2026 season.

"The Tasmanian government is delivering key investments to help keep our economy strong and create jobs in Tasmania," Mr Rockliff said.

USAFL Executive Director Doren James said the partnership was thriving - with "unprecedented growth" for the USAFL past year, including record participation rates.

"The support of Tasmania is instrumental as we strive to build on this momentum with the implementation of a fresh marketing strategy this year," he said.

He said the USAFL was committed to showcasing Tasmania as a unique tourist destination, provider of highquality products and a reputable brand.

Mr Rockliff said the recent attainment of an AFL club license created new avenues for market expansion in the US.

He said the introduction of the Tasmania Devils club added to this opportunity.

Opposition Leader Dean Winter has called on the state government to develop a clear plan to prioritise Tasmanian contractors in the construction of a new stadium at Macquarie Point, as critics lined up to slam Labor over the timing of its surprise policy backflip.



# **Battle heats** up in big Mac design

## 'Exciting announcement' in next few days

Proponents of Macquarie Point Stadium 2.0 will make an "exciting funding announcement" in the next few days to intensify the two-horse race for a 23,000-seat multi-purpose venue at Mac Point.

Despite Sports Minister Nic Street's "captain's call" on ruling out the alternative project, Mac2 is back in the game after Labor's stunning backflip to support a multi-purpose venue in Hobart as well as announcing its support for the commercially driven waterside Mac2 project.

Stadia Consortia managing director Dean Coleman, who has driven an innovative proposal for a stadium as part of a \$2.3bn Macquarie Point urban redevelopment, welcomed Labor's policy pivot.

"We welcome their support for our project and we are working hard to get all of our steps in place," Mr Coleman said. "We have been consulting closely with major investors and we will hopefully have an

exciting funding announcement this week.' Mac2 stadium is a roofed,

23,000-seat venue, expandable

to 30,000 when demand out-

strips seating availability. The innovative design protrudes about 200m into the Derwent on its eastern side, and digs into the Cenotaph

hillside on its western side. The outer "skin" includes 450 apartments, a private hospital, hotel and convention centre, restaurants, supermarket, retail, RSL and Tasmanian Football Museum spaces.

"We are proposing a project that delivers significant cultural and community benefits beyond the economic and sporting aspirations of this once-in-a-lifetime project," Mr Coleman said.

"The consortia's vision is for a community precinct that all Tasmanians can be proud of, and which will stimulate Hobart's cultural and tourism sectors as Wrest Point did in the 1970s and Mona has done in the past 10 years.

"Our proposal doesn't take

up the whole site allowing room for other projects such as the Aboriginal Truth and Reconciliation Park."

Labor leader Dean Winter, who replaced Rebecca White after the election, said his party would now support the building of a stadium to promote employment opportunities.

"A stadium will mean thousands of jobs in construction, including hundreds of apprenticeships," Mr Winter said.

"That's why Labor will be backing a new stadium."

With the state government putting the pieces in place for a Macl stadium, Mr Street is not onboard with a Mac2 alternative, following his statement last month.

"The project includes a full roofed stadium as per the AFL agreement. Funding has been allocated and the formal planning process is under way," he said. "Given its commitment to deliver the Macquarie Point Urban Renewal Project, the Tasmanian government is not contemplating involvement in any alternate proposals."
